REGULAMENTO REGULATION

1. ABOUT THE CONTEST

The 1st International Photography Contest- Madeira, promoted by Regional Secretary of Education, Science and Technology (Regional Directorate of Education/ Artistic Expressions Services Department) results from the need felt by the Visual Arts teachers to have motivating activities for their students, envisioning the use of technological resources that are available to them, working and developing their skills associated with image, such as lighting, colour, framing, composition and visual textures.

It is well known that the student's contact with art promotes aesthetic and cognitive development and visual acuity, as well as it gives them more confidence to express their feelings and emotions freely and responsibly. Therefore, appears the 1st International Photography Contest- Madeira, a pedagogical event addressed to students with aged 10 to 18. The teachers/schools are fully responsible for submitting the works (photographic records for the contest).

The works selected by the jury will be part of a collective exhibition to be held in a museum in the Autonomous Region of Madeira.

2. ATTENDANCE CRITERIA

2.1- The contest is open to all students born between 2004 and 2012.

2.2- It is full responsibility of schools to submit the images, as well as to obtain the necessary authorizations to comply with this regulation.

2.3- The theme of the contest addresses the preservation of the environment and intends to illustrate nature through **macro images** that portray **natural details** aesthetically attractive (photo editing is allowed but there will not be accepted any image showing photomontage).

2.4- To participate in the contest, each photograph must include the Identification form (attachment 1), which should be filled in on the computer. Handwritten and scanned forms will not be accepted.

2.5- Each participant can only submit one **picture**, in **JPEG or PNG format**, with the best possible quality. Each picture must be identified in the file with the country-school-student's name (eg: portugal-ebsfunchal-antonio_morais) and sent via wetransfer to expreplastica.dsea@edu.madeira.gov.pt, together with the Identification form.

2.6- Submissions that enter the above email until 23:59 on 15th May 2022 will be considered valid. The contest organisation cannot be held responsible for any problems or technical malfunction of any network services or telephone line, online computer systems, servers, informatic services, software, technical problems, human error, network, or webserver congestion or any of the previously mentioned combined, including any problem or damage in the participant's computer or of any other person related or resulted from the participation or download of any of the Contest materials.

2.7- Photographs will be grouped in three categories:

2.7.1 – Category 1 – Students born between 2004 and 2006;

2.7.2 – Category 2 – Students born between 2007 and 2009;

2.7.3 – Category 3 – Students born between 2010 and 2012;

2.8- All images will be evaluated by an independent panel of juries with relevant and acknowledge competences in the field of photography that will choose the three best works from each category, as well as all the works that will be part of the collective public exhibition carried out in Autonomous Region of Madeira (dates and venue yet to be announced)

2.9- The list of winners, as well as all the works selected for the exhibition, will be announced until the 15th June, 2022, in <https://www.madeira.gov.pt/dre/>

2.9.1 – The winners of all the different categories will be awarded a certificate and a trophy.

2.9.2- A certificate will be awarded to all participants in the exhibition.

2.10 – The jury's decision is final and sovereign, therefore it will not be possible to appeal against it.

2.11 – The Institution promoting the contest reserves the right to disqualify and exclude all works that do not fulfil the following requirements:

2.11.1 – To be original and authorship of the enrolled student.

2.11.2 – To be correctly identified as indicated in the contest regulation.

2.11.3 – Do not show any detail that may identify the participant, nor contain faces that allow identifying people.

2.11.4 – Do not contain any threatening, false, misleading, abusive, hostile, libellous, derogatory, obscene, or pornographic content.

2.11.5 – Do not contain any material that can represent or encourage any conduct that may be considered a criminal offense, originate civil accountability, or otherwise violate any law.

2.11.6 – Do not violate copyright, registered trademarks, contractual obligations, or any other intellectual property rights of any third person or entity, or that violate the privacy or publicity rights of any person. Therefore, the works must not have: registered trademarks; copyrighted materials owned by others; names or other characteristics that allow the identification of celebrities or other public figures, living or dead; entries in which a participant may have bought or assured the image usage rights; entries that contain any commercial content that promotes any type of product or service.

2.12 – When submitting the image to the contest, each participant assures the acknowledgment and acceptance of all the contest conditions and that the registration complies with every rule.

2.13 – Each participant agrees in owning the inherent consequences of the noncompliance of any of the regulation items.

2.14 – By submitting the image to the contest, each participant keeps all the credits, however, agrees and authorizes its use for exhibition and promotion purposes by the organization, such as:

2.14.1 – Public display in exhibitions promoted by the organizing Institution;

2.14.2 – Inclusion on websites and social networks associated with services of the organizing Institution;

2.14.3 – Inclusion in press articles associated with services of the organizing Institution;

2.14.4 – Inclusion in any promotional materials developed by the services of the organizing Institution;

2.15 –The organizing Institution, as well as its partners, does not take any responsibility for the unauthorized
